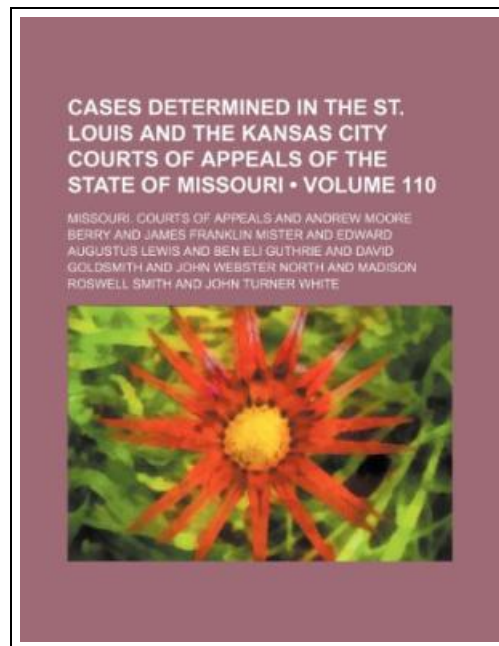

The authorities are all agreed on this point. And under certain of said authorities, they were not bound to return them, nor even offer to rescind the contract, but they might have retained them and set up defect in quality in diminution of the purchase price. But when they returned a part of the nails and received credit for them and used the residue in their business, and thereby exercised ownership over them, their acts in so doing amounted to an acceptance and to a waiver of the defects in the quality of the nails. They thus not only received the goods, but in law they accepted them; which precluded them from making a defense on a suit for the purchase price that they were not as warranted. The excerpt from Mr. Benjamins work makes a clear distinction between a receipt and an acceptance of goods under a sale. Instructions number two and three given at the instance of the plaintiff are objected to as improper. They have no relation to the case whatever. But as they could not have been applied by the jury to the facts, we do not see how they could have prejudiced the defendant. I am of the opinion that plaintiff was entitled to a judgment on the pleadings. It was no defense to merely allege that the nails were defective and that defendants had paid full value for them.
