In the Applied regression analysis, the autoregressive models, moving average models and combined autoregressive and moving average models have a wide number applications. The study on autoregressive process/models is considered to be essential to both the theoretical and applied statisticians. The first order and higher order autoregressive models for regressed variable and errors have been described by giving auto covariance functions.
