Title V of the GLBA requires financial institutions to provide notice to customers of a possible disclosure of non-public personal information to non-affiliates and an opportunity to opt out of such disclosure. This non-public information includes an individuals address, as well as Social Security number, telephone number, and mothers maiden name. The prohibition against disclosure of this information without notice and the ability to opt out are subject to statutory exceptions provided in the GLBA. The GLBA's privacy rule for re-disclosure binds recipients of non-public personal financial information.
