

Mr. Wharton, in his Pleading and Practice (8th ed.), 733, concedes that a defendant can, by express statutory authority, waive his right to a trial by jury on a plea of guilty. We are of opinion that our statute (Code Crim. The right to be tried by the court alone may be as invaluable, in the opinion of defendants in some misdemeanors, and under some circumstances, as is the trial by jury in lower grades of felony. In misdemeanors, on a plea of guilty, the law provides thus for two modes of trial in fact; and it seems to us, from the wording of the statute, that it...
