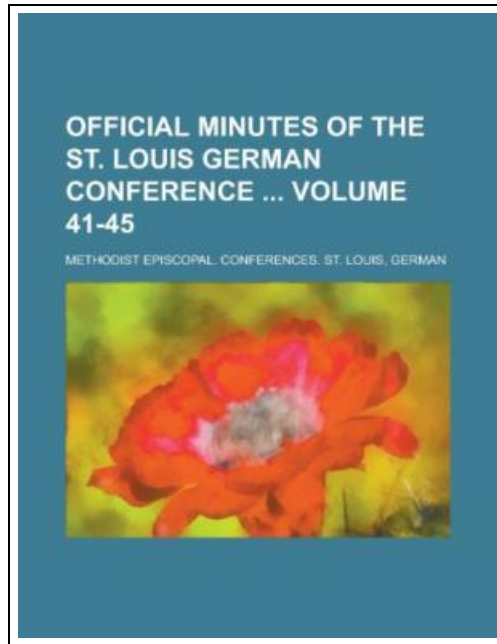

We also reviewed the performance contracts of area office directors for fiscal year 2009 to identify performance measures related to billing and collection activities.
