

Man puts his capital into a business venture. He buys goods. He finds a place to house and display the goods which he offers for sale. He uses money as the medium for the transaction of business. In this you will notice two functions which go on more or less regularly, namely, buying and selling. When he buys, he creates obligations. The things possible for him to buy may be classified as goods, services, privileges. When he buys goods he gets something tangible to offset the obligation. When he buys services (clerk hire) or privileges (license) he gets nothing tangible to offset his obligations. Whenever you create an obligation without getting something tangible in return for it your capital will be decreased. Decreases in capital are called losses. When a loss is a temporary one and has as its purpose the making of profit it is called expense. When you sell goods at a price higher than cost you increase your capital. You sell either for cash or on account. In the latter case you charge some one who becomes indebted to you. Increases in capital are called gains or profits. Gains which are being made regularly and on which the business depends are called income. These various things suggest certain classes of transactions for which accounts would be needed, for example: from sales Arranged somewhat differently, you might say to show their relation to the business, they would appear...
