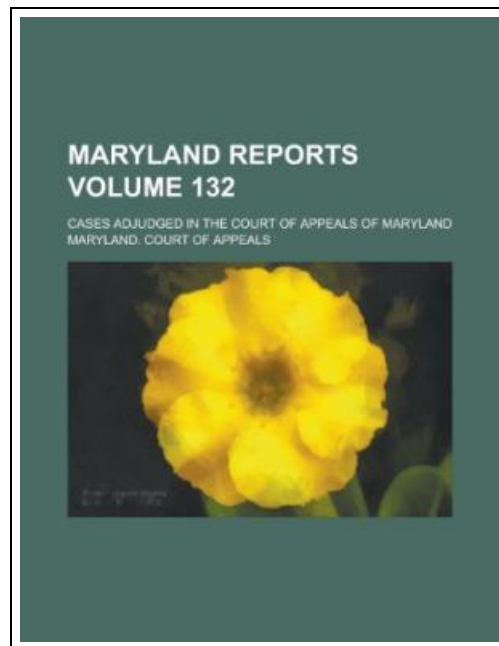

P-385 If a subsequent Act can be made, by any reasonable construction, to stand with previous legislation, that construction will always be adopted. P-385 This is especially true of Acts passed at one and the same session of the Legislature; in such cases there is a strong presumption against an implied repeal, and they are to be construed together, if possible, so as to give effect to each.
