

There is evidence in the case that there was the appearance of a horse having fallen in the road just before entering upon the bridge. Two witnesses testify to this, and to finding a small strap in the road at that point, a short time afterthe accident. The plaintiff says the horse fell upon the bridge. But whether the horse ever came in contact with the alleged defect. The case was left, therefore, to be decided by mere inference, without facts to determine which of the inferences, was correct.
